Strategy description

The FCT 1e 25 ESG strategy is a multi-manager sustainable investment strategy independently defined by the FCT 1e Board of Trustees and made available to FCT 1e company affiliates and insured members.

The investment strategy is diversified across equities (25%), bonds and real estate. The funds used integrate Environmental (E), Social (S) and Governance (G) dimensions into the investment process. The strategy is rebalanced monthly back to target weights.

The strategy is appropriate for investors with a low capacity / willingness to take risks and an investment horizon of 3 or more years.
